

**PAPER TITLE SHOULD START 2 LINES BELOW START OF PAGE
FONT: ARIAL, BOLD, SIZE 12. CENTERED**

Affiliations in Arial Font, size 12, style plain, 1 line below authors

ABSTRACT

Abstract starts two lines below affiliation. Like all other sections, the section title is centered, capital, Arial font size 11, plain style. Text is Times-new-Roman, size 10, which starts 6 points (half a line) below title. Unlike other sections, abstract text is in italic. Abstract size is about 300 words.

1. INTRODUCTION

Start each new section by a title that is at least one line below the preceding section. Section titles are centered, capital, Arial font, size 11, plain style and numbered, except for Abstract, which is not numbered.

Text starts 6 points below title, in Times-new-Roman font, size 10 and plain style.

Each new paragraph is 6 points below preceding one, and starts with no indentation.

1.1 Sub-Title

Sub-titles are numbered as shown. They are justified left, title case, Times-new-roman font, size 11, style plain.

1.2 Paper Language

Page language is English.

1.3 Paper Size

Paper size is expected to be about 6000 words. For the papers that will be selected for publication in IEEE/CPT or ASME/JEP, an extra charge may be applied to papers that exceed a certain length in terms of the number of pages.

1.4 Page Size, Margins and Columns

Page size is A4, with a margin of 2cm (0.8 inch) all around (top, bottom, left and right). Except for paper title, authors and affiliation, all paper text is arranged in two equally sized columns (8.29 cm each) separated by 1cm. In the first page only, paper title starts 2 lines below the 2cm top margin.

1.5 File format

Acceptable file formats are MSWord (.doc) or a compliant PDF file (see attached instructions).

2. EQUATIONS, TABLES AND FIGURES

Each equation starts on a new line indented by 0.5 cm:

$$E = m c^2 \tag{2.1}$$

Equation number is right justified. You may number equations either by section or consecutively for the whole text. All symbols should be defined at the first use. A nomenclature section can be added, to replace definitions inside the text, but this is not mandatory.

Tables are preceded by a numbered table caption, which should be centered and bold. Numbering should be consecutive for the whole paper. Tables should be referenced in the paper like the example Table 1.

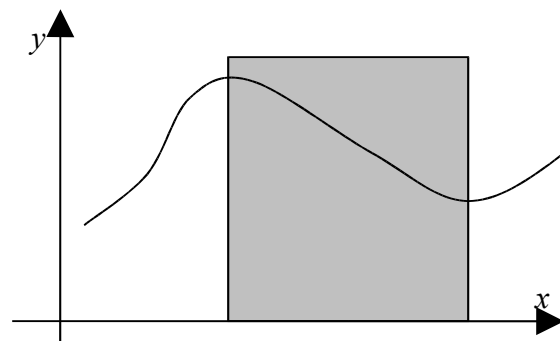


Figure 1. An example to show how a figure is placed in a table

The same rules apply to figures, except that the caption should be below the figure. **Both figure and its caption should be placed in a table without borders.**(Fig. 1).

3. HEADERS AND FOOTERS

The header of the first page should contain the fixed text:

*Thermal Issues in Emerging Technologies,
ThETA 2, Cairo, Egypt, Dec 17-20th 2008*

(Times New Roman, Italic, size 12, centered). The header of subsequent pages will contain your paper title and authors, using the same format, but the total should not exceed 1 line:

*My paper title, abridged if needed to hold in 1
line, author 1 et al.*

As for the footer, it should contain:

- The following text is centered: “ThETA2/” followed by your paper reference number (see mail sent to you when the abstract was first submitted)
- Page number/total number of pages aligned right as shown.

4. REFERENCING

Every reference should be cited in the text between square brackets [1][2]. The reference cannot be the start of a sentence. The reference section will be in font size 9.
